WHEREAS, the Thirty-Sixth Supplemental Declaration to Declaration of Covenants, Conditions, and Restrictions for High Desert Residential Properties (Tract 11B, High Desert) was recorded on May 11, 2000, as Document No. 2000046065 in Book A5, Page 5885, in the Office of the County Clerk of Bernalillo County, New Mexico (the "36th Supplemental Declaration");

WHEREAS, the Thirty-Eighth Supplemental Declaration to Declaration of Covenants, Conditions, and Restrictions for High Desert Residential Properties (Desert Mountain at High Desert) was recorded on November 28, 2000, as Document No. 2000117817 in Book A12, Page 7373, in the Office of the County Clerk of Bernalillo County, New Mexico (the "38th Supplemental Declaration");

WHEREAS, the 34th Supplemental Declaration and 38th Supplemental Declaration identify maintenance responsibilities for the High Desert Residential Owners Association, Inc. (the "Association");

WHEREAS, the 38th Supplemental Declaration subjected additional property to the terms of the 34th Supplemental Declaration such that all of the real property known as Desert Mountain at High Desert Village is subject to the provisions of the 34th Supplemental Declaration;

WHEREAS, the 34th Supplemental Declaration may be amended by the affirmative vote or written consent of the majority of the Voting Members of Desert Mountain at High Desert Village; and

WHEREAS, the Voting Member(s) of Desert Mountain at High Desert Village and the Association desire to amend the 34th Supplemental Declaration as follows;
