Legends Landscape Maintenance Expense FY 2023: The Board packet included an agreed upon plan for the landscape maintenance plan for The Legends.

Wilderness Village - Grass removal/Xeriscape: The Board packet included a proposal from Yellowstone for the removal of existing turf in Wilderness Village. The Board

discussed the proposal and a motion was made by Camille Singaraju and seconded by Bob Howell to defer action on the proposal. The motion was carried unanimously.

The Bylaw proposal passes if it has 75% or more of the weighted votes, in accordance with the Bylaws, Article 6.6

1623* 75%= 1217.25 is 75% of the weighted votes.

You will notice that there is a shortage of votes.

Pinon Point has 70 votes, but it is missing one Voting Member so, for this election Pinon Point only has 35 votes.

Mountain Highlands has 68 Votes, but it is missing one Voting Member so, for this election Mountain Highlands only has 34 votes.
