*Tip from our Crime Awareness Liaison* - Auto burglaries are often committed as crimes of opportunity. Thieves will look for anything of value, including the loose change you might have in your car. They will break in or open an unlocked door, looking for anything of value. Keep your valuables, even if it's your gym bag with dirty socks, out of sight and keep your car locked and in the garage, if possible.

*New Board Nomination and Election Procedure* – At the February Board Meeting, the Board approved a new procedure for selecting Board candidates and conducting the Board election at the annual meeting. Some of the content had previously resided in the Nominating Committee Charter and the remainder follows practices that have been refined over the past several years to choose Board Directors effectively and fairly. *Reporting Dog Problems* – Have you encountered an unleashed or unmanaged dog repeatedly? If you have tried talking to the neighbors with no luck, the City of Albuquerque, asks that you call 311 and give as much information to the operator as you can.

*High Winds and Gates* – As we are approaching our windy season, here is a reminder of the protocol for Gated Villages. If winds are projected to be 20 mph or over, HOAMCO will hold the gates open. Opening the gates during these times mitigates excessive wear-and-tear on the swing arms and gear boxes, and potential wind damage.

*Help us Stop Irrigation Leaks* - Yellowstone will begin turning on irrigation in High Desert at the beginning of March. While HOAMCO regularly drives through the community, they may not catch all drips or irrigation leaks so, if you see any leaks, please call the HOAMCO office at 505-314-5862 or the after-hours emergency line at 505-221-0189.

*New Construction Committee (NCC) Changes* – At the January Board Meeting, the Board approved two changes to the Guidelines for Sustainability: 1) any NCC applications shall require the compliance with all NCC guidelines, and resolution of any HOA violations prior to consideration for approval, and 2) any building envelope adjustment or variance from the HOA NCC guidelines shall require unanimous approval by the quorum of the NCC present. The revised Guidelines for Sustainability will be posted on the High Desert website.

*Planning Changes to your Yard?* – If you're planning changes to your landscaping, please remember that plants in public areas must be from the <u>Approved Plant List</u> and changes to public areas must be approved by the Modifications Committee. The <u>approval form</u> is available on our website. Please note, plants have many different common names like Chamisa and Rabbit Bush. When looking for a plant, if you do not see the common name look up the scientific name and do a search. Often times you will find the plant you want.
